

OR


to suppress or delete anything considered objectionable ("Censor" def. 4 b)

## 2024 Book Ban Data

Most book challenges and calls for censorship are initiated by groups.

These groups often include concerned citizens, elected officials, boards and leadership entities, and administrators (American Library Association).

These groups of censors comprised 72% of the total books bans in 2024 in both school and public libraries (American Library Association).

# 2024 Book Ban Data Cont.



The American Library Association's Office for Intellectual Freedom reported 821 cases against library books and resources in 2024.


Since the pandemic, numbers have fluctuated but have remained higher (American Library Association).



# NOTABLE CASES

# Florida



In the 2023-2024 school year, Florida had around 4,500 book removal incidents (Soule).



In the 2024-2025 school year alone, Florida removed or placed restrictions on over 2,300 books (Soule).



According to PEN America, the state remains Number 1 in the US in book removals across school libraries (Soule).

# **Outcomes**

"Anybody who's been paying attention to this knows that a lot of the book-banning tactics are starting in Florida and then are actually influencing how books are banned across the country."

- Setting trends for other states to follow
- Could it lead to more?

# Little v. Llano County

- 17 books were removed from county libraries by the government of Llano County
- 2023- A group of residents sued the library system to get the books returned to the libraries.
- The district court agreed with the plaintiffs at first and ordered the county to return the books to the library shelves.
- 2025-The Fifth Circuit Court of Appeals reversed the district court's ruling.
- Ruling: Not a violation of the First Amendment because the county has the right to make those decisions for its residents ("Appeals Court Reverses Ruling in Texas Book Ban Case").

# Little v. Llano County Outcomes

1. Could set a precedent for other counties and states to follow.

- 2. Raises an argument over community values vs. free speech.
- 3. Libraries can make their own decisions about what to include on their shelves.

# Arkansas Bill-Act 372

- "Harmful to minors": Criminal penalties of up to a year in jail for librarians
- Designated "adult" section of libraries to house books "inappropriate" books ("Libraries, Bookstores, and Readers Unite to Fight Arkansas' Restrictive Censorship Laws").

#### **Outcomes**

- Sections 1 and 5 were determined to be unconstitutional in September 2024 (Peet).
- Defending readers' right to choose and librarians' discretion to curate
- Brings attention to issue of "content segregation" in libraries

# PROBLEMS WITH CENSORSHIP

# Effects on Authorship

## **Reduced Income**

- 1. Decrease in sales
- 2. Loss of royalties

## Reputation

- 1. Fear of not receiving book contracts
- 2. Concern about losing audience members

# Effects on Authorship Cont.

## "Self-Censoring"

1. Fear of writing new books on certain topics because of banning

#### **Demoralization**

- 1. Loss of self-esteem and feel that their work is not valued
- 2. Emotional pain and mental health damage

## Safety

1. Attacks in public places and on social media (Maughan).

"I've gotten death threats via email or people saying, 'You must suffer from some kind of mental illness in the fact that you think you need to indoctrinate an entire generation of kids.' But indoctrinate how? For kindness and empathy, and loving people like they're your brothers and sisters?" (Craft).

# Effects on the Publishing Industry

#### **Financial**

- 1. Challenged livelihood and increased risks for librarians
- 2. Temporary increase in sales before drop
- 3. Decrease in revenue due to lost sales
- 4. Loss of author relationships





#### Resource overuse

- 1. Additional time and money spent on legal counsel to protect the company and authors
- 2. Filing lawsuits to advocate for books

# Effects on the Publishing Industry Cont.

# Hesitancy to publish books on certain content

Reluctance to publish books containing controversial content:

- 1. Fear lack of sales and monetary loss
- 2. Fear damage to reputation

## Decreasing progress

Stifling and canceling diverse voices the industry has been working to increase and protect

## Effects on Readers

"When kids grow up not seeing themselves in books they grow up feeling like they don't matter" (Smith).

#### Demoralization

Feel their own life experiences are not valid

Struggle to feel relevant in a society that does not depict who they are or their beliefs

## Decreasing access to literacy

Decreasing access to literature that sparks interest in reading

Loss of interest=loss of reading

# Greatest Overall Effect on Readers and Authors

## Attacking personal freedom!

Authors' voices are being shut out of society.

**Violation: Freedom of Speech** 

Readers everywhere lose the right to choose what they want to read.

Violation: Individuality and Freedom to Choose/Consent

# How Can We Help?

## Advocacy

- ✓Continue with advocacy groups such as the American Library Association and PEN America.
- ✓ Publishers keep fighting against book bans and legislature that permits such practices.

# i.e Penguin Random House and the Authors' Guild

✓Citizens and lawmakers make more informed decisions and attempt to remove bias from choices.

# Support

- ✓Support local libraries and check out books.
- ✓ Follow book ban challenges and legal proceedings and question and speak out.
- ✓Support authors whom you like to read and even those you don't know about. (check out books, donate to causes, post on social media, etc.)

# Where Are We Headed?

Step 1

A group or entity wants something removed for their benefit.

They call for books to be removed and claim societal justice or victory. Step 2

If no solution is reached, the pull for censorship grows.

Authors and publishers feel unsupported and threatened and start to submit,

Literary merit is destroyed because books lose content that makes readers think, question, or deem it relevant or interesting. Step 3

The reputation of publishing and literature crumble.

Society allows the effects to trickle to other areas.
